We wish to advise that the subject Policy is due for Renewal on June 1, 2022.

Our review of the performance of this Group Health Plan indicates that it continues to have a meaningful impact on the Members and has proven its value.

In addition to the Plan's experience the Insurer needs to consider the current trend of rising healthcare costs and ensure that adequate reserves are made. This helps to cushion the amount of any future premium increases that may be charged in the event of abnormal/shock claims and/or excessive Benefit utilization during a given period.

A review of the Census data shows that the current Membership has reduced by 29% with 57% of membership in the Senior Members Division. The contractual requirement for Senior Membership was not exceed 25% of all the overall members on the plan.

With the expiration of the 12 months pre-existing condition limitations and the decrease in membership the performance of the plan has been extremely unfavourable and is expected to continue to deteriorate unless drastic changes are made.

Therefore, following renewal option of a 25% rate increase is chosen for the period June 1, 2022, to May 31, 2023.

BENEFIT ADJUSTMENT

- 1. Medical Deductible increased from \$300.00/\$900.00 to \$500.00/\$1,500.00 for Plans 1 to 3.
- 2. Senior Members Division Medical Deductible increased from \$500.00/\$1,000.00 to \$750.00/\$1,500.00.
- 3. Co-insurance changed from 80% 20% to \$75% 25% on Medical, Dental and Vision benefits on all divisions.
- 4. Maternity Caesarean Section benefit to be changed from benefit payable as surgery to Flat \$8,000.00 for Plans 1 to 3.
- 5. Dental Maximum reduced from \$3,500.00 to \$2,500.00 on all divisions.
- 6. Dental deductible increased from \$100.00 to \$150.00 on all divisions.
- 7. Vision Maximum reduced from \$1,500.00 to \$1,200.00 on all divisions.
- 8. Contact Lenses reduced from \$750,00 to \$600.00 on all divisions; and
- 9. Vision deductible increased from \$100.00 to \$150.00 on all divisions
